## Perot running mate visits Boise

Ross Perot's vice-presidential candidate, James Stockdale, made a brief stop in Boise yesterday afternoon as part of a Northwest campaign tour. Police estimated that 300 people attended a rally at Perot's Boise headquarters welcoming Stockdale and his wife, Sybil, to the City of Trees.

Earlier this week, Perot claimed that the Republican Party threatened to smear his daughter in the media, prompting Perot to drop out of the race last July. Much of Stockdale's short speech was obviously intended to support Perot's allegations.

"I believe Ross Perot," Stockdale told the crowd. "He is an honest man. He is not playing games with us. I believe now that his heart was in it all the way."

Sybil Stockdale took the microphone briefly to support her husband and Perot. "They're going to keep our country from going broke. They're going to save our country for our children, and grandchildren, and great-grandchildren."

Most of the people in attendance Monday appeared to be proud Perot supporters. "I think he'll take Idaho," said Clayne Chaumell, 58, a Boise aircraft mechanic. "I've been a Democrat all my life, but I'm voting for Perot. Both parties are scared to

death of him, and he's got enough money to back up what he's doing. They damn near gotta pay attention to him."

Indeed, more and more people are paying attention to Perot. Some national polls show Perot with more than 20 percentage points. According to a poll taken in Idaho last weekend, 40% of registered voters say they'll vote for Perot. The same poll showed Bush and Clinton tied at 22% while 13% of those polled were undecided.

Many of yesterday's rally participants were college and high school students. "Everything's in chaos and needs to be fixed. It's that simple," said Craig Bissell, 18, of Boise. "This nation is in a mess and I really believe that Perot has ideas that will make things work. Bush has proved that he can't do it, and I don't know how Clinton thinks he can do it."

But not everyone was head-over-heels about Perot. "I'm not into his gas tax," said Jill Sermon, a BSU freshman.

"I'm worried that if we elect him that everything will stagnate," commented Matt Chasan, a freshman at Albertson College. "He'll want to get his way, but Congress may not let him."

Before he faces Congress, however, Perot must face the voters next week.

## Marriott and Student Development officials patch mixed-up meal plans

The drama of the meal plan mix-up came to a conclusion yesterday. Following the student forum held on Tuesday, October

20, a group of Marriott and administration officials met with the Food Service Regional Representative. After discussing the options that came out of the NNC "think tank," a decision was made and implemented immediately.

The original change from traditional to block plan was made this past summer. Hills explains, "We were trying to respond to the matter of losing meals . . . that's the constant gripe we've heard over the past four years."

Then came all the problems, and the

administration's attempts to rectify them quickly. As the fliers distributed in the cafeteria explained, several options were extended to students. The first of these was to upgrade their current meal plan and add 20 meals to the total for \$20.00. Because the term is almost half over, this basically allows a participant in the "10-meal" block plan to upgrade to the "14" block plan and a member of the "14" plan may transfer to the "19" plan. The second option was to make a direct exchange from a block plan to the traditional setup. This alternative eliminates the flexibility previously enjoyed, but does give the student his/her entire 10, 14, or 19 meals per week. The final possibility is to do nothing and keep the current block setup for the rest of the term.

The meal-plan format for future terms, however, is still up in the air. A food task

force will be "set up to review for next quarter," offered Ken Hills of Student Development. Only a few specifics are in place at this point. "The fact is, we'll have to go one way or the other. Not to say some change couldn't take place, but ... you can't have both quantity and flexibility under the current contract. Now, if the students pushed hard enough and said 'Well, we'd like to try another plan,' we're willing to have that expanded. We might be able to negotiate with Marriott if they're willing to go with that."

But as for now the students of NNC may breathe a sigh of relief. Nobody should run out of meals before term's end, and healthy relations between students, Marriott, and Student Development will be maintained. As NNC Food Service Director Dick White commented, "I think most people are going to be alright."

Residents were evacuated and the Nampa Fire Department was called when a fire set off Sutherland Hall smoke alarms Sunday.

Two full size fire trucks, a fire chief's suburban, and a bomb squad arrived at Sutherland at about 10:20 p,m, Sunday night in response to a 911 call by Betty Hellenga, whose husband Dean is resident director for the sophomore dorm.

"When the alarm went off, I went out into the hall to make sure that all of my guys were getting out," said RA Mark Pierson. I went upstairs to see if it was a prank, to see if someone had pulled the alarm as a joke, and I saw the smoke. I met up with Dean [Helenga] and Jared May, and grabbed the fire extinguisher."

Pierson said, "Jared held his breath and disappeared into the bathroom, when he discharged his extinguisher and came out, I went in. I held my breath and shot my extinguisher at the heating element."

Fireman Jack Thompson, after returning from the ill-fated bathroom, explained: "So far, all we can tell is that someone left the

"When you mess with the extinguishers, you mess with peoples' lives," added Dean, "There is an automatic \$200 fine for anyone caught playing with an extinguisher, no questions asked."

Upper east wing residents were allowed back into their rooms at about 11:10 p.m., almost an hour after the fire was discovered. RAs Eric McGrath and Matt McCaslin were at work cleaning up the dusty chemicals leftover from the fire extinguishers late into the night.

"Well, we won't be using the sauna for a while." said Eric McGrath, upper east's RA. "There were no serious burns on anyone or damage to property. There was a little smoke inhalation, but nothing along the lines of a serious injury. It's a good thing that everyone reacted as fast as they did, or someone might have been hurt. ## Fitch honored as outstanding educator for 1992

Dr. Philip A. Fitch, executive director of the California Commission on Teacher Credentialing, received the 1992 L.E. Wesche Award on Monday. The Wesche Award, named after Dr. Lilburn Wesche, director of graduate studies and interim Academic Dean at NNC, is awarded for outstanding service to education.

"Building the confidence and esteem of others through strong human relationships is essential to the quality of public educa-

#### tion," said Fitch.

Referring to recent Idaho statistics which state that 30% of students kindergarten age and higher receive local and federal aid, 50% are from separated and mixed families, 25% live below poverty level, and 25% are abused, he stressed that "the role of the educator is changing. In the face of the breakdown of domestic life, we hope that bettering education will give rise to stronger families."

Fitch cites his 25 years of junior high and senior high school teaching as the inspiration for his

work as executive secretary of the Commission on Teacher Credentialing for the State of California. "There is nothing more important than preparing teachers in their relationships with students. A teacher's goal is the building of concepts and esteem in others."

Accordingly, Fitch stressed that teachers owe honesty about themselves and their discipline to students, a view which he attributes to his education at NNC, which provided him with "the belief and value system necessary in public and government structure."

Personally surprised by the

Christian influence in community and federal schooling and administration, Fitch stated that it is a Christian's responsibility to act in strengthening the government in any way he or she can.

"Christ compels us to work with people in their greatest need, whatever the situation," Fitch commented. "The public education system provides a medium for such work."

Fitch, a graduate of NNC, holds masters degrees and a doctorate at the University of Idaho and earned a Specialist in School Administration at Washington State University. In addition to his position in junior high and senior high school teaching and principalships, he has been Assistant Superintendent of Schools, Director of Education and Education Graduate Studies at two colleges, Commissioner for Teacher Credentialing, and President of the California Council on the Education of Teachers. He has also completed three extended periods as visiting professor and participant at universities and institutes in 19 countries in Western and Eastern Europe and Northern Africa.

## Flat tax would increase U.S. revenue

The U.S. federal tax system is in trouble. Revenues from income tax are declining despite the Internal Revenue Service's massive efforts to curb rampant tax fraud and evasion. The rising cost of tax collection combined with declining revenues is a recipe for disaster. One effective way to deal with this difficulty would be for the U.S. Congress to pass a law replacing the progressive federal incometax with a flat federal sales tax.

The first reason the income tax should be replaced by a flat tax. is that the collection of revenue needs to be simplified. The current income tax system requires employed individuals to file an annual tax return stating the amount of income they earned and any deductions or exemptions to which they are entitled. The bureaucratic task of processing millions of these returns is highly complex. If a flat federal sales tax was collected instead of an income tax, the individual would no longer file a tax return. Instead, businesses would collect the tax, based on a fixed rate, from the individual every time a product or service is sold.

Secondly, a federal sales tax will not only make paying taxes easier, but will also make tax evasion more difficult. A sales tax is harder to evade than an income tax. Right now people lie on their tax returns so that they pay less tax than they actually owe. Because millions of tax returns are sent to the IRS each year, the Internal Revenue Service cannot audit everyone to insure each person pays the precise amount of tax he owes. Making false claims on tax returns would be part of the past if a flat federal tax was implemented. Instead of giving each person the opportunity to estimate the amount of federal tax he owes, a fixed percentage of the cost of every item or service he bought would be paid as tax to the federal government. The only way to not pay federal sales tax would be to not spend money.

Thirdly, besides being harder for the individual to evade, a flat federal sales tax would be less expensive for the IRS to collect. By simply eliminating the need for tax returns, the Internal Revenue Service could save a substantial amount of money. The dollars spent to employ thousands of workers to process tax returns could be used in more productive ways if a flat federal sales tax was implemented. For example, a computer system could be established to link businesses with the IRS, making tax collection even easier. Because a federal sales tax would be collected more efficiently than the present income tax, the number of disputed taxes would be drastically reduced. This means the Department of Justice, especially the Tax Court, would have a reduced case load thus allowing taxpayers' dollars to fund more important governmental functions.

Lastly, in addition to saving money, a flat federal sales tax would result in increased revenue for the U.S. government. Efficient tax collection will naturally bring more money into the United States' Treasury. But beyond that, the replacement of the federal income tax with a sales tax will prompt people to earn more money. Since income brackets will no longer dictate a higher percentage of tax from those who earn high incomes, more people will aspire to higher income levels. It is only logical that when people earn more money they will spend more money. As increasing amounts of goods and services are bought, more sales tax is collected.

Although a flat federal sales tax will bring more revenue to the U.S. Treasury and save the government money, it will not solve every problem. Some critics of the flat tax argue that the poor will pay more taxes if a flat federal sales tax replaces the progressive federal income tax. In order to correct this situation, all food and rent should be free from the federal sales tax. I understand this may not solve the problem entirely. But considering the complexity of the U.S. tax system, there are no easy solutions.

## No Always Means

All women fear rape. However, the crime of rape goes beyond being accosted in the middle of the night by a stranger. Although statistics vary, most estimate that half of all rape victims are attacked by someone they know. In a large number of cases, the rape occurs in a dating relationship. Date rape occurs on every college

campus. Already this fall, at least one NNC student was reportedly raped by a fellow student.

A student currently at NNC, Lisa, has experienced the trauma of date rape. She had known the man who raped her for about a year, and they had dated on and off within that year.

"We were at his house late at night, and he told me to take my clothes off, and I wouldn't. He wouldn't listen to my objections. I was afraid to even move once I realized what was happening. I thought it was my fault. I couldn't talk about it for months." "I thought it was my fault."

Lisa is not alone in her feelings. Many women believe that they provoked the rape and feel that they somehow are responsible for being raped. However, women who are date raped are not responsible for their assailants actions. Demonstrations of affection on a woman's part do not make her liable for intercourse.

"I couldn't talk about it for months."

Since women who have been date raped feel a tremendous amount of guilt and shame, they are less likely to report the rape to authorities. Even now, women that she gave consent to intercourse.

In a legal setting, police or lawyers will ask pointed questions that will seem to place the blame on the victim. Despite this, women must report date rape if for no other reason than to stop the rapist from doing it to another woman.

Lisa did not report the rape. Consequently, the rapist was never punished. "He went around bragging about our encounter," she said. "He thought he gave me a real good time. He still doesn't acknowledge even treating me

bad."

who bring charges against dates face a high burden of proof. The belief that "she asked for it" is still prevalent in today's society. If a woman does

take legal action it is likely to be dismissed by police as an unfounded charge, especially if kissing and petting occurred prior to the assault because they may believe my fault." "I tried to talk to my mom about it, but she couldn't admit that something that bad was possible. She liked the guy and wasn't sure what to believe. Other girls he went out with

wasn't sure what to believe. Other girls he went out with after me called me a slut. I never felt any support; I felt guilty that somehow I asked for it, and no one wanted to hear my side."

"No one wanted to hear my side." No one can control what others say or think about the incident. So date rape victims must keep talking until someone believes them.

Another factor which contributes to the rape victim's silence is fear that she will not be believed, even by her family or friends. In many cases family support is cut off, like in Lisa's case.

A woman should not isolate herself from her peers. Her true friends will be understanding and supportive. Also, it is always good to seek the advice and support of a counselor, particularly one who is experienced in counselling rape victims.

"It was as if a part of me died on that night. After three months I had a nervous breakdown. I had nightmares every night. I never thought anyone would degrade me the way he did. I never wanted to have a guy touch me again. I thought no one would ever want to love me after that."

"I never wanted to have a guy touch me again." The process of victimization occurs well after the actual rape. Many times in date rape, the woman has trusted the man completely. This breach of trust makes future relationships hard for many women who have experienced date rape and also causes women to wonder about trusting their own judgement and feelings. With time and the help of sensitive friends and professionals this trust can be regained.

"I have put the shattered parts of my life back together. I can still believe I am a good person--that I didn't ask for it. No one deserves to be overpowered, and no one should ever make you do things you don't feel comfortable doing. I deal with the flashbacks as they come. Date rape can happen--I never thought it would happen to me. You can learn to trust again if you are willing to work through the pain. That's the hope.'' 'Date rape can happen.''

The harsh reality is that women are raped. Therefore, they fear it. However, prevention does not mean that women have to stay inside their homes and lock their doors.

Women should not be so intimidated that they forever "stay in their place." The Victorian view of women as a victim who is hunted down by male predators has no place in today's society. However, women must be cautious when dating. But they must not stop living because it is impossible to know who will be a rapist.

In her book, <u>If You Are Raped</u>, Kathryn M. Johnson gives some prevention suggestions for dating relationships. "Try to learn something about a new date before going out with him. Arrange to meet in public areas. Set up double-dates." If something does happen despite these precautions, a woman should call the police or the local rape crisis center.

Date rape is still not taken seriously in today's

That's the hope." society. People say that "the girl asked for it," because of the way she dressed or acted. However, no woman asks to be raped. Rape occurs anytime a man forces a woman to comply with his demands against her will. Just because a woman is willing to kiss or be touched by a man does not imply that she is willing to have sex. When a woman says "no" to advances of sexual intercourse she means no. No always means no.

## Toronto Blue Jays topple Atlanta Braves in World Series

## Obadiah's mixes espresso and evangelism

Armed with a dream, Katie Robinson decided to do something big in Boise.

"Boise never really had a good place to meet people or talk with someone," says Katie, a BSU student

And so she opened Obadiah's coffee house at the 8th Street Marketplace.

But it's not all that simple.

The story of Obadiah's begins in Amsterdam, where Katie spent six months with a Youth With A Mission (YWAM) program. Coffee shops were very popular there, she says, and many Christian organizations sponsored friendship evangelism ministries through these coffee shops.

"My heart has always been in friendship evangelism," Katie explains. "It's a way to reach people that can't be reached through the church."

When she returned to Boise, Katie's pastor asked how the church could better reach college students. And Katie told him about the coffee shops.

Supported by her church

(Vineyard Christian Fellowship), Katie and a friend, Trina Arritola, started getting things together.

An empty restaurant pad (which had been vacant since Godfather's Pizza closed three years ago) at the 8th Street Marketplace was offered temporarily without rent, eliminating the big uncertainty of where the coffee house could be established.

"So many people were willing to donate time, money, and things," says Trina.

"None of us had any idea how to open a business," Katie relates. "The reason why we're open now is totally the Lord. So many times we wanted to give up, but the Lord helped us stick with it. Other coffee shops told us we'd never make it, that it would never fly."

But it did.

After months of organizing endless details and enduring many hardships, Katie, Trina, and friends opened Obadiah's in early August. The response has been overwhelming.

Without any real marketing efforts -- except a few coupons passed out to people on the street -- Obadiah's has experienced sur-

"Already people have been saved," Katie says with a smile, knowing that her dream has become a reality. "A lot of these people hate to be preached at and have been hurt by the church. We've reached them by being there for them, by being their friend and giving them our genuine love. It's through our actions that we're seen, not our words."

Denise echoes Katie's sentiment: "My biggest prayer is that I could be a servant to the saved as well as the unsaved. Hopefully, people will see Jesus in us."

As a part of its ministry, Obadiah's hosts a young adults meeting on Monday nights from 7 -9 p.m.

"It's a worship time and a teaching time where people can get to know each other," explains Trina, emphasizing the laid-back atmosphere. "Wear your sweats and Birkenstocks."

But Obadiah's primary ministry takes place during regular business hours. Over 50 volunteers have caught Katie's vision of evangelism and espresso. Workers represent Christ's love to customers while mixing mochas and Italian sodas.

"Considering that it's a volunteer organization, I feel that the atmosphere and service are very professional," states Matt Johnson, an NNC senior. "It's as good as any coffee house I've been in."

Obadiah's menu ranges from the house coffee and espresso drinks to fruit juices and soft drinks. And for the adventurous beverage-seeker, Obadiah's offers several creative concoctions, including Strange Brew and Travis' Travesty (which tastes like hot Frankenberry milk, according to junior Paul Register). Most drinks are under \$2.

As the workers are volunteers, much of Obadiah's revenue is set aside for the future, when the organization plans to cut ties with Vineyard Christian Fellowship to become a non-denominational, self-supportive operation.

"We're just trying to save right now, because obviously we won't be rent free forever," Katie explains.

Volunteers and customers alike are excited about Obadiah's future independence. Because its lease is temporary, Obadiah's is unable to alter the plain decor of the current building. But the staff is searching for a permanent location.

Since Obadiah's opened twoand-a-half months ago, the building's owner has received three lease offers (though no one wanted to lease the space during its three-year vacancy). Obadiah's is considering a larger location nearby, with enough room to accommodate an entertainment stage, a study room with a minilibrary, and -- eventually -- a deli.

"Sometime in the future we'd like to expand to include a deli, called The Lighter Side, that focuses on business people," Katie says. "But it all depends on what building we get. And once we find a permanent space, we'll change the decor and make it more appealing."

Katie is confident that the right place will be found: "God's hand has been on this project from the beginning."

Obadiah's is looking for volunteers. "It's really fun to work here, and it's a good ministry opportunity," says founder Katie Robinson.
